The City Ordinances require permits for the construction, alteration, removal, or demolishing of any building within the corporate limits of the City of Fayette, MO., except ordinary repairs and minor alterations costing not more than \$1000. They further provide that when any wall structure, building or part thereof shall be constructed, altered or removed without such permit, it shall be torn down or removed, and the expense incident thereto shall be recovered from the owner. There shall be no obstruction of the streets, alleys or other passageways without the permits. All contractors and/or owners shall inform themselves as to zoning, water and sewer connections, the availability of electrical service, distance from existing property lines and such other items that may affect the said construction, alteration, removal or demolition "BEFORE" any construction, alteration, removal or demolition is begun.

In consideration of the issue and delivery of the above permit, the holder agrees that all the provisions of the Plumbing and Electrical Codes of Fayette, Missouri and all State Laws pertaining to buildings will be complied with, whether specified or not, and further agrees to save indemnify, and keep harmless the City of Fayette, Missouri its officers and duly appointed representatives against all liabilities, judgments, costs and expenses which may in any wise accrue by reason of issuance of this permit or occupancy of above stated premises

The Building Permit fee referenced in the incorporated building code shall be calculated as follows:

A base fee of \$25.00 plus a fee based on the estimated value of the construction of \$2.00 per \$1000.00 of anticipated value. If the anticipated value of the structure exceeds \$300,000.00, there shall be an additional flat fee of \$500.00 over and above the other charges set out in this section.
