CALL TO ORDER

ADDITIONS TO AND APPROVAL OF AGENDA

Alderman Shiflett motioned to approve the agenda with additions of discussion/ and approval for Fourth Class Cities. Alderwoman Ford seconded the motion. Six voting Aye. Motioned carried.

APPROVAL OF THE MINUTES OF THE MEETING HELD ON MARCH 3, 2020

Alderwoman Ford motioned to approve minutes for the March 3, 2020 meeting minutes. Alderwoman Smith seconded the motion. Six voting Aye. Motioned carried.

<u>DISCUSSIONS AND/OR APPROVAL OF PARK BOARD RECOMMENDATIONS FOR</u> PLACEMENT OF ADAPTIVE EQUIPMENT BY HCSSB / 2020 POOL RATES

Alderman Wells motioned to approve farm land lease to Mike Hustedde for \$3,900.00. Alderman Shiflett seconded the motion. Six voting Aye. Motioned carried.

<u>DISCUSSION AND/OR APPROVAL FOR THE PRINTING OF FOUTH CITIES OF AMERICA BOOKLETS</u>

Alderman Shiflett motioned for printing of booklets of the Fourth Cities of America in black/white at .75 cents a copy and the extra cost for cover stock for extra \$4.00. Alderwoman Smith seconded the motion. Six voting Aye. Motioned carried.

LISA ASBURY AND JOCELYN HUTCHINSON WITH ADVANTAGE TAX SERVICE FOR PAYROLL SERVICES

Alderman Cook motion to hire Advantage Tax Services for emergency 4 month payroll service for The City of Fayette. Alderman Wells seconded the motion.

Roll Call Vote: Ayes -6: Alderman Cook, Alderwoman Smith, Alderwoman Ford, Alderman Dimond, Alderman Wells, Alderwoman Smith and Alderman Cook. Nays -0. Motion carried.

PUBLIC WORKS DIRECTOR/BUILDING INSPECTOR COMMENTS

Public Works Director Danny Dougherty stated he has spoken with Utilities Supervisor Christine Fuhlage and she is willing to represent the City of Fayette in the Regional Water Committee.

Alderman Wells motioned for Christine Fuhlage to be a representative from the City of Fayette on the Regional Water Committee. Alderman Shiflett seconded the motion.

Roll Call Vote: Ayes – 6: Alderman Shiflett, Alderman Smith, Alderman Wells, Alderman Dimond, Alderwoman Ford, Alderwoman Smith and Alderman Cook. Nays – 0. Motion carried.

CITY ADMINISTRATOR/CITY CLERK COMMENTS

Intern City Administrator report was included in the packet. Mr. Hancock reported the Utility office did not do shut off due to many citizens being laid off from the COVID-19 threat.

Mr. Handcock suggested a cleaning company come to sanitize and clean City Hall. Mr. Handcock stated he would get bids for this service.

Mr. Hancock presented the Council with a City Administrator / City Clerk job description. Council members are asked to look over the two jobs descriptions. Discussion of separating the two jobs and what duties each will partake will be discussed at the next Board Meeting of the Aldermen Meeting April 7, 2020.

Mr. Hancock reported he has been going through the current fiscal budget and looking into the upcoming budget.

CITY ATTORNEY COMMENTS

Nathan Nickolaus, City Attorney stated an emergency declamation should be drawn up, Mr. Nickolaus stated he would have an ordinance for the next Board of Alderman.

Mr. Nickolaus stated upcoming April election has been postponed, Alderman Cook will be a sit in for Mayor Greg Stidham.
