CALL TO ORDER

The regular meeting of the Board of Aldermen of the City of Fayette was called to order at 6:00 p.m. November 28, 2023 by Mayor Jeremy Dawson.

ADDITIONS TO AND APPROVAL OF AGENDA.

Alderwoman O'Connell motioned to approve the November 28, 2023 agenda with the addition of Item #3 to New Business. Alderwoman Ishmael seconded the motion. Five voting Aye. Nays – none. Motion carried.

PUBLIC HEARING BEGINS

Mayor Jeremy Dawson opened the Public Hearing regarding the voluntary annexation request from GL Rentals, LLC at 6:03 p.m.

The first public comment came from Amber Overfelt of Howard Electric Cooperative stating that Howard Electric would like to provide electricity to the new annexed property. She stated that Howard Electric was willing to enter into a Franchise Agreement with the City at the rate of five percent as well as a Territorial Agreement that would state that Howard Electric Cooperative would be the power provider for the area.

The second public comment came from Judy Strodtman of Public Water District #1, stating that the District would like to continue serving water to the annexed property.

Alderwoman Ishmael seconded the motion. Five voting Aye. Nays – None. Motion carried.

Roll Call Vote: Ayes: Alderwoman Broadus, Alderwoman O'Connell, and Alderwoman Galloway. Nays: Alderwoman Ishmael and Alderwoman Gerlt.

Alderwoman Broadus motioned to approve <u>BILL NO. 2023-15</u>, <u>SECOND AND TITLE ONLY READING OF AN ORDINANCE AMENDING THE CITY CODE CHAPTER 420 PERTAINING TO FLOOD PLAINS</u>. Alderwoman O'Connell seconded the motion. Three voting Aye. Nays – two. Motion carried.

Roll Call Vote: Ayes: Alderwoman Broadus, Alderwoman O'Connell, and Alderwoman Galloway. Nays: Alderwoman Ishmael and Alderwoman Gerlt.

- 5. First Christian Church is donating a Maple Tree in memory of Jim Lanham to be planted near the lower shelter house at Fayette City Park
