ADDITIONS TO AND APPROVAL OF AGENDA.

Alderwoman Ford motioned to approve the July 11, 2023 agenda with the correction of removing the words 'Adjournment Sine Die' from the title of the swearing in ceremony of Ronda Gerlt. Alderwoman Broadus seconded the motion. Five voting Aye. Nays -0. Motion carried.

Alderwoman Galloway motioned to approve the minutes for June 27, 2023. Alderwoman Ford seconded the motion. Five voting Aye. Nays -0. Motion carried.

ROLL CALL

Roll Call verified six Board members present for the meeting.

Responding to the Roll Call: Alderwoman Ronda Gerlt, Alderwoman Marsha Broadus, Alderwoman Michelle Ishmael, Alderwoman Peggy O'Connell, Alderwoman Becky Galloway and Alderwoman Stephanie Ford.

CITY STAFF REPORTS

CITY MARSHAL DAVID FORD

City Marshall David Ford reported that the city has received the title for the Humvee vehicle and requested that it be put up for bid.

Mr. Ford reported that the new vehicle that has been placed on order will be here in one month and asked the council if the Explorer that is currently being used by the police department should be put up for bid or to be kept for large events. No decisions were made by the council regarding both vehicles.

Mr. Ford discussed whether phones should continue to be provided by the city to the police department and certain employees. Attorney Nathan Nickolaus stated that since the court could subpoen the employee for either the city phone or personal phone that they use, the city should not provide phones, but provide a stipend to the employee according to how much they use their phone for their job.

PUBLIC WORKS DIRECTOR DANNY DOUGHERTY

Public Works Director Danny Dougherty gave a report on the construction of the Spring Street Bridge.

CITY CLERK JUDY THOMPSON

City Clerk Judy Thompson asked for approval to attend Missouri Lagers HResource meeting; a free training in Jefferson City on July 19, 2023.

Alderwoman O'Connell motioned to approve the Missouri Lagers training for Mrs. Thompson on July 19, 2023. Alderwoman Ford seconded the motion. Six voting Aye. Nays -0. Motion carried.

Mrs. Thompson reported that the Missouri Employers Mutual (MEM) Workman's Compensation audits were completed. The 2021-2022 audit resulted in a credit of \$31,492.00 and the 2022-2023 audit resulted in an amount due of \$15,296.00. The final credit of \$16,196.00 was received from MEM by check.

CITY ATTORNEY NATHAN NICKOLAUS

City Attorney Nathan Nickolaus presented information on the Fayette City sign code, giving several examples of different kinds of signs and different amounts of time that signs should be displayed. Alderwoman Galloway asked if vulgarity such as bad language was allowed on signs and Mr. Nickolaus stated that vulgarity was not prohibited under the current code but obscenity was.

Alderwoman Broadus asked when the hole created from a street repair in front of her house, would be fixed. Mr. Dougherty stated that it has to settle before they fill it with concrete.

Alderman Broadus reported that a vehicle was parked in the right of way near her house.

Alderwoman Peggy O'Connell

Alderwoman O'Connell asked if a road tax could be put on the ballot. Mayor Jeremy Dawson stated that it could not be put on the ballot this fall, but could be put on the ballot in the spring.

Alderwoman Bekki Galloway

Alderwoman Galloway stated that the Tree Board was working on a plan for trees with Dakota Wells.

Mrs. Galloway asked if a review of occupancy could be done on 301 N. Linn St. She stated that Angie Malone used to do rental inspections. Mayor Dawson stated that he would look into it.
