REGULAR MEETING OF THE BOARD OF ALDERMAN OF THE CITY OF FAYETTE, MISSOURI TUESDAY, MAY 14, 2024

CALL TO ORDER

The regular meeting of the Board of Aldermen of the City of Fayette was called to order at 6:00 p.m. May 14, 2024 by Mayor Greg Stidham.

PLEDGE OF ALLEGIANCE

Everyone in the Chamber rose for the Pledge of Allegiance led by Alderwoman Stephanie Ford.

ROLL CALL

Roll Call verified five Board Members present for the meeting.

Responding to the Roll Call: Alderwoman LeeAnna Shiflett, Alderwoman Stephanie Ford, Alderwoman Marsha Broadus, Alderwoman Michelle Ishmael, Alderwoman and Peggy O'Connell.

Alderwoman Ronda Gerlt was absent.

ADDITIONS TO AND APPROVAL OF AGENDA.

Alderwoman Ford motioned to approve the May 14, 2024 agenda. Alderwoman Ishmael seconded the motion. Five voting Aye. Nays – none. Motion passed.

APPROVAL OF THE MINUTES OF THE REGULAR MEETING OF THE BOARD OF ALDERMAN HELD APRIL 23, 2024

Alderwoman Ford motioned to approve the minutes of the Regular Meeting of the Board of Alderman held April 23, 2024. Alderwoman Shiflett seconded the motion. Five voting Aye. Nays – none. Motion passed.

CITY MARSHAL DAVID FORD

City Marshal David Ford had no comments

PUBLIC WORKS DIRECTOR DANNY DOUGHERTY

Public Works Director Danny Dougherty stated that he had spoken to OWN Engineering Company about the Green Acres Drive sewer project.

Mr. Dougherty reported that the Electric Department had replaced several poles and workers would be working on a project at Central Methodist University this coming weekend. CMU and Little Dixie Construction will share the cost of the overtime pay for the City Electric workers.

City of Fayette: Board of Aldermen Meeting Minutes, May 14, 2024

Mr. Dougherty reported that his crew had been working to get the pool prepared, but the rain was hindering the painting of the pool. The pool may not open on Memorial Day weekend if work is not complete.

Mr. Dougherty reported that two large pieces of equipment had broken down but there were no funds budgeted for repair them.

CITY CLERK JUDY THOMPSON

City Clerk Judy Thompson reported that work was being done on the budget and meetings with Alderwomen would soon begin.

Mrs. Thompson reported that the annual ARPA report had been completed and a Workmen's Comp audit was underway.

Mrs. Thompson stated that she had been working to get lifeguards hired and trained before the opening of the pool.

Mr. Beford reported that only nine more counties out of 112 in the State of Missouri need to become Purple Heart Counties to make the state complete.

Regina Powell

Regina Powell shared her concerns regarding chopping down trees by the old vacant funeral home. Mr. Dougherty will check into it.

Ms. Powell shared other concerns including loose dogs chasing people, micro fiber lines going in and speeding through the area near the new townhouses.

Rebecca Felten

Rebecca Felten shared information regarding the danger of annual immunizations for dogs and asked the board to consider changing the ordinance to reflect a three-year immunization.

Alderwoman Ford motioned to approve Pay Resolution 2024-10, approving invoices for payment and salaries in the total sum of \$337,721.20 which includes, General Fund \$83,627.44, Electric Fund \$183,019.25, Water Fund \$21,831.74, Sewer Fund \$49,242.77. Alderwoman O'Connell seconded the motion. Five voting Aye. Nays – None. Motion passed.

Alderwoman Broadus seconded the motion. Five voting Aye. Nays – None. Motion passed.

Alderwoman Ford motioned to approve BILL NO. 2024-10, BY SECOND AND TITLE ONLY READING OF AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF FAYETTE MISSOURI, AUTHORIZING THE MAYOR TO SIGN AN MPUA MUTUAL AID AGREEMENT. - 4. Alderwoman Ford motioned to approve the line-item request from the Electric Department to purchase various operating supplies in the amount of \$668.00. Alderwoman Ishmael seconded the motion. Five voting Aye. Nays None. Motion passed.
- 5. Alderwoman Ford motioned to approve the line-item request from the Electric Department to purchase various line materials to restock supply in the amount of \$20,715.61. Alderwoman Broadus seconded the motion. Five voting Aye. Nays None. Motion passed.
