City Administrator, Ms. Deanna Cooper, informed the Council that KPM CPA Auditor firm out of Springfield has agreed to take the City of Fayette on as one of their clients for auditing services. The cost for is \$25,000 for one year audit plus \$5,000 for additional Grant audits if required.
